# POLICY : ASSESSMENT AGENCY AFFILIATION

### (SAFETY SKILL DEVELOPMENT FOUNDATION)

### 1. INTRODUCTION

An effective, consistent and quality-assured assessment enables the qualifications to gain recognition, credibility and value in an education and skills ecosystem. It is important that everyone involved in the assessment of candidates, undertaking qualifications, takes steps to ensure that the qualifications are trusted by learners and employers. Learners want the assurance that the assessment is fair and that judgment of their competence is the same as that for all other candidates. Employers want to be sure that holders of qualifications have been assessed against all the outcomes described in the qualification.

This **Policy for Assessment Agency Affiliation** ensures that only quality driven organizations meeting the criteria get empaneled with **Safety Skill Development Foundation** (SSDF).

### 2. OBJECTIVE

The objective of this policy document is to define a standard criterion to evaluate the Assessment Agency for affiliation with SSDF, having the capabilities and experience to assess the trainees trained in outcome-oriented training in the job roles in line with QPs/ NOS and having potential to undertake assessment as per the structured procedures.

### 5. SCOPE

The policy deals with affiliation/re-affiliation/provisional affiliation of the assessment agencies with SSDF, their evaluation criteria, the documents required and process to be followed.

### 6. REQUIREMENTS/ PREREQUISITES FOR AFFILIATION OF AAs

- a. An AA should be a legal entity (Company or Society <u>but not firms, proprietorship or</u> <u>individuals</u>; limited liability Partnership (LLPs) are allowed.
- b. Following documents will be submitted by AA before affiliation -
  - 1. ITRC of last three years
  - 2. Article/Memorandum of Association under Company Act 1956, if society then Society Bylaws& other related documents
  - 3. PAN and TAN/GST (if applicable) in the name of Organization
- c. The Assessment agency should have a secure Website for publishing information about their organization.
- d. Details of assessors should also be available on its website with state-wise details (assessors' name, qualifications, experience and photograph along with the details of assessor affiliation).
- e. The Assessment Agency should be recognized with NCVET.
- **7. CONFLICT OF INTEREST** A Training Provider cannot ordinarily be appointed as an Assessment Agency and No sub-contracting or franchising would be permissible for assessments.

### 8. PROCESS

Following process will be followed for affiliation/re-affiliation/ provisional affiliation of assessment agencies. New Assessment Agency will be initially provisionally affiliated and then regular affiliation will be granted after evaluation as per guidelines & process.

### a) Fresh empanelment/affiliation of AAs through RFP process (need based)

- a) The empanelment/affiliation of new Assessment Agencies will be through open RFP and need based. The RFP will be planned based on projected requirements of Assessment Agencies to be empaneled through that RFP.
- b) Sub limits on number of AAs to be affiliated State-wise may be published in RFP. The applicants in the RFP will be evaluated as per criteria mentioned in TABLE A. A merit list will be prepared as per evaluation scorecard and desired number of applicants will be provisionally affiliated for 6 months and a provisional affiliation certificate will be awarded.
- c) During the six months, the new AAs will be assigned batches for conducting assessment on the basis of the certified assessors aligned with them.
- d) The provisionally affiliated AAs will be evaluated at the end of their validity period for affiliation with SSDF and AAs meeting the criteria will be affiliated on regular basis for one year(from the date of original provisional affiliation)

### b) Affiliation/Re-Affiliation of AAs

- a) At the end of the expiry of validity period of affiliation (i.e. 6 months for provisionally affiliated AA and 1 year for existing affiliated AAs), Assessment Agencies will be re-evaluated on the parameters as per **Table B**
- b) The AAs will be affiliated with SSDF for a period of 1 year after successful evaluation and scores achieved as per parameters given in **Table B**.

### 9. OTHER INFORMATION

### A. Fee Structure for affiliation of AAs will be as under.

The same shall be revised every after a period of two years:

### B. Audit

In the event of complaints / reports about poor performance / unfair practices against an AA, the SSDF reserves the right to terminate the affiliation.

### C. Grievances Redressal

Any grievance against non-affiliation/affiliation will be by grievance committee of SSDF. The decisions approved by the CEO, SSDF will be final and binding.

### **10. CONFLICT RESOLUTION/DISPUTE**

In case of any dispute of conflict decision of CEO, SSDF will be final & binding.
